## Objectives of this Proposal

- ◆ To provide an opportunity that will allow for more equitable (sub-regional) representation at Ex-com Meetings
- ◆ To foster greater participation by all GRULAC members at Ex-Com meetings

### Introduction

The Executive Committee comprises of:

- Seven (7) members from Article 5 and
- Seven (7) from non-Article 5 parties,

selected each year by the Meeting of the Parties


### Introduction

- ◆ Two (2) permanent seats are available to GRULAC (except for every four years when the rotating (additional) seat comes to GRULAC)
- Each member can co-opt two (2) other members whose participation at the meeting would be funded by the MLFS
- Each Ex-Com member serves for a term of one year
  - ♦ GRULAC has agreed in principle to allow members to serve for two consecutive terms




## Current Membership Arrangement

B – Elected member B1, B2 co-opted members




Rotating Seat C – Elected member C1, C2 co-opted members

# Proposal Continued Scenario 1

- Scenario 1 assumes that the two Ex-Com seats are held by: one member from Central America (CA) and another member from South America (SA)
- In this Scenario, each member would be required to co-opt one other member from their sub-region and the second co-opted member from the sub-region that is not a member







In this Scenario each sub-region will have equal representation of two delegates

# Proposal Continued Scenario 2

This Scenario will be applicable every four (4) years when the rotating seat comes to GRULAC







In this scenario every sub-region is represented by the delegates

## Rotating Seat

- It is proposed that:
- (1) the rotating seat be a one (1) year term based on the already existing policy of two consecutive terms for the permanent seats
- (2) that the rotating seat be rotated among the sub-regions every four years
