Part 1

Current Practices in UNEP

UNEP's Rule 69

1. **International** non-governmental organizations having an interest in the field of the **environments**, referred to in section IV, paragraph 5, of General Assembly resolution 2997 (XXVII), **may** designate representatives to sit as **observers** at **public** meetings of the Governing Council and its subsidiary organs, if any. **The Governing Council shall from time to time adopt and revise when necessary a list of such organizations. Upon the invitation of the President or Chairman, as the case may be, and subject to the approval** of the Governing Council or of the subsidiary organ concerned, **international** non-governmental organizations may make oral statements on matters within the scope of their activities.

UNEP's Approach to Stakeholder Engagement

- Nine Major Groups *and Stakeholders*
- Accreditation for *international* Major Groups organizations
- Participation in GC only as observer with opportunity to provide oral statements
 - Participation in GC: seats allocated to 9 MGS in COW and GMEF
 - Participation in ministerial roundtables
 - Participation in sessional committees
- Access to un-edited working documents of the GC and submission of written input
- Global Major Groups and Stakeholders Forum
- Regional Consultations Meetings
- Major Groups Facilitating Committee

Part 2

The Rio+20 Legacy

UN Conference on Sustainable Development (Rio+20), June 2012

- ❑ **Paragraph 88** on strengthening and upgrading UNEP as the **leading global environmental authority** that:
 - 1) Have secure, stable, adequate & increased financial resources
 - 2) Coordinate environmental activities in UN system
 - 3) Promote strong science-policy interface
 - 4) Disseminate evidence-based environmental information
 - 5) Provide capacity-building & facilitate access to technology
 - 6) Consolidate HQ functions & strengthen regional presence
 - 7) **Ensure participation of all relevant stakeholders**

First Universal Session of UNEP Governing Council/Global Ministerial Environment Forum, February 2013

- ❑ Decision 27/2 on institutional arrangements – new governance structure for UNEP
- ❑ 58-membership Governing Council changed to “**United Nations Environment Assembly of UNEP**” (UNEA) by the General Assembly (March 2013)

Implementation of Paragraph 88 h

Decides that the governing body will ensure the **active participation** of **all relevant stakeholders**, particularly those from **developing countries**, drawing on **best practices and models** from relevant **multilateral institutions** and will explore new **mechanisms** to promote **transparency** and the **effective engagement** of **civil society** in its work and that of its subsidiary bodies, *inter alia* by:

- Developing by 2014 a process for stakeholder **accreditation** and participation that **builds on the existing rules** of procedure and takes into account **inclusive** modalities of the **Commission of Sustainable Development** and **other relevant United Nations bodies**;
- Establishing by 2014 mechanisms and rules for stakeholders **expert input and advice**;
- Enhancing by 2014 working methods and processes for informed discussions and contributions by all relevant stakeholders towards the intergovernmental decision making process;

Stakeholders Expectations

- New Mechanisms to go beyond current UNEP rules and procedures and practices, no regression
- UNEP to set new standards in the United Nations
- Application of the 11 Principles in the spirit of Principle 10
- **Strengthening participation at the regional level**
- **Meaningful** participation in Agenda Setting, Decision Making and Implementation
- Use of new communication and information technologies
- Full Transparency

Principles of Engagement

1. Right to full and effective participation in all activities including planning, agenda setting, decision and policy-making, implementation, and evaluation
2. Timely and easy access to all information and documents, including negotiating documents and proactively disseminate information
3. Full participation: access to all UNEP meetings, processes and bodies (including through the final stages of decision-making) at all levels; speaking rights in all meetings, as a rule; the right to submit documents
4. Right of self-organization, including selection of their respective representatives

Levels of Engagement



Agenda-setting

- Policy shaping
- Global political agenda setting
- UNEA agenda setting



Decision-making

- Policy deliberations leading to decision-making
- Transparency and access-to-information



Implementation

- Strategic partnerships for implementation of UNEP's policies
- Strategic partnerships for achieving sustainable development

Expert input and advice

Meaningful Participation in the UNEA

- Participation in Agenda Setting *and* Decision Making
- Access to all meetings of the UNEA and its subsidiary bodies, including the opportunity to intervene and to provide written inputs
- Timely access to draft decisions
- Transparency on how MGS input was addressed in decisions
- Use of all UN languages
- Major Groups and Stakeholder Fora before open ended CPR and UNEA, to allow MGS to coordinate positions and to prepare input

Engagement with the CPR

1. Access to all meetings of the CPR, including in thematic debates for expert input and advice, informal consultations with the CPR, to achieve MGS engagement in agenda setting *and* decision shaping;
2. Timely access to written documents, including drafts;
3. Opportunity to intervene in debates and negotiations, submit written contributions/comments/recommendations

Scientific input

- The International Resource Panel
- The Foresight Process
- The GEO process

Expert input opportunities:

- Environment and Social Safeguards
- Embedding Environmental Sustainability into SDGs/Post-2015

Inclusive Stakeholder Engagement Approach

- Effective, broad and balanced participation by region and by type of organization, through accreditation
- Expansion of the stakeholders from the nine Major Groups identified in Agenda 21 to other stakeholders, including those who are potentially affected by decisions/policies
- Creation of thematic groupings of relevant Major Groups to provide input

Enhanced Participation through Use of ICT

- Use of modern information and communication technology to facilitate and broaden participation
 - webcasting of CPR and UNEA meetings
 - virtual participation
 - access to information platforms

Experts Group Report

- Expert Group was put in place to prepare for the ED “Report of Experts on New Mechanisms for Stakeholder Engagement at UNEP”
- Members: Jochen von Bernstorff, Lalanath deSilva, Sandor Fulop, Joyeeta Gupta, Patricia Kameri-Mbote, Nora McKeon, and Marcos Orellana, with Stephen Stec as Rapporteur.
- Final report received October 25

Some Views of Experts

- Committee on World Food Security as a good practice
- UNEP is not bound by the current nine Major Groups approach
- A new Environmental Civil Society Mechanism (ECSM) with increased powers of self-organization and with regional representation
- More involvement of social movements and citizens organisation (affected groups)
- Accreditation for national NGOs, government registration not required

Some Views of Experts II

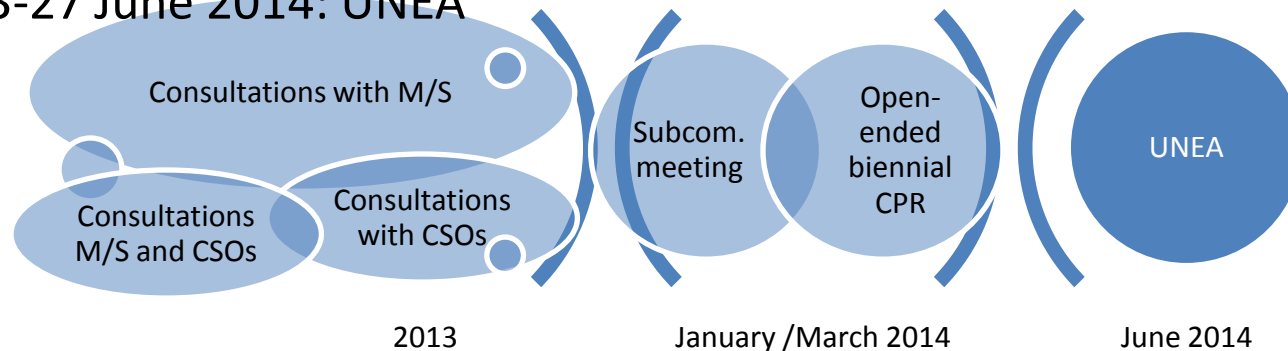
- The ECSM would include representatives of some of the existing Major Groups system, but would not include business and industry, local governments, and science and technology, which would instead be included in a new and separate Advisory Body
- In UNEA, CPR, etc. the number of seats allocated to the ECSM to fill could vary depending on the function, within the three main areas of decision-making, agenda setting, and implementation. The Group considered a good model would be to allocate seats at a ratio of 1-5-1 (business – ECSM – local governments).

UNEA 2014

UNEP's NEW GOVERNANCE STRUCTURE

United Nations Environment Assembly (UNEA)

- Universal membership
- Meets biennially starting in 2014
- Concludes with a 2-day high level segment

Committee of Permanent Representatives (CPR)

- Missions accredited to UNEP

Other Meetings

- Regular quarterly meetings, ad-hoc meetings, thematic debates and briefings

Open-ended Meeting

- Meets in even years for 5 days

Subcommittee Meeting

- Meets annually for five days

UNITED NATIONS ENVIRONMENT ASSEMBLY OF UNEP (UNEA)

- ❑ **Decision 27/2, Para 5 . *UNEA to take strategic decisions and provide political guidance:***
 - (a) Setting the global environmental agenda;
 - (b) Providing overarching policy guidance and defining policy responses to address emerging environmental challenges;
 - (c) Undertaking policy review, dialogue and exchange of experiences;
 - (d) Setting the strategic guidance on the future direction of the United Nations Environment Programme;
 - (e) **Organizing a multi-stakeholder dialogue;**
 - (f) Fostering partnerships for achieving environmental goals and resources mobilization.

- ❑ **First UNEA to take place from 23-27 June 2014 in Nairobi**

- ❑ **Governed by Rules of Procedure** (to be amended)

COMMITTEE OF PERMANENT REPRESENTATIVES (CPR)

- ❑ **Decision 27/2, Para 9. *CPR is the subsidiary inter-sessional body of the UNEP governing body***
 - (a) Contribute to the preparation of the agenda of its governing body
 - (b) Provide advice to its governing body on policy matters;
 - (c) Prepare decisions for adoption by its governing body and oversee their implementation;
 - (d) Convene thematic and/or programmatic debates;
 - (e) Promote effective ways and means to facilitate participation of the non-resident members of the Committee, particularly from developing countries
 - (f) Perform any other functions delegated to it by its governing body;

UNEP'S OPTIONS PAPER

- New inclusive accreditation criteria;
- Two types of consultative status to be granted to non-governmental observers;
- Participation in global environmental agenda setting; and in meetings of the Bureaus of UNEA and CPR, for agenda setting in UNEP;
- Participation in all meetings of the CPR;
- Thematic clusters for expert input and advice;
- Nine major groups plus approach or UNEP's identification of its own groups, versus a more open civil society approach;
- Stakeholders facilitating body;
- Funding mechanism.

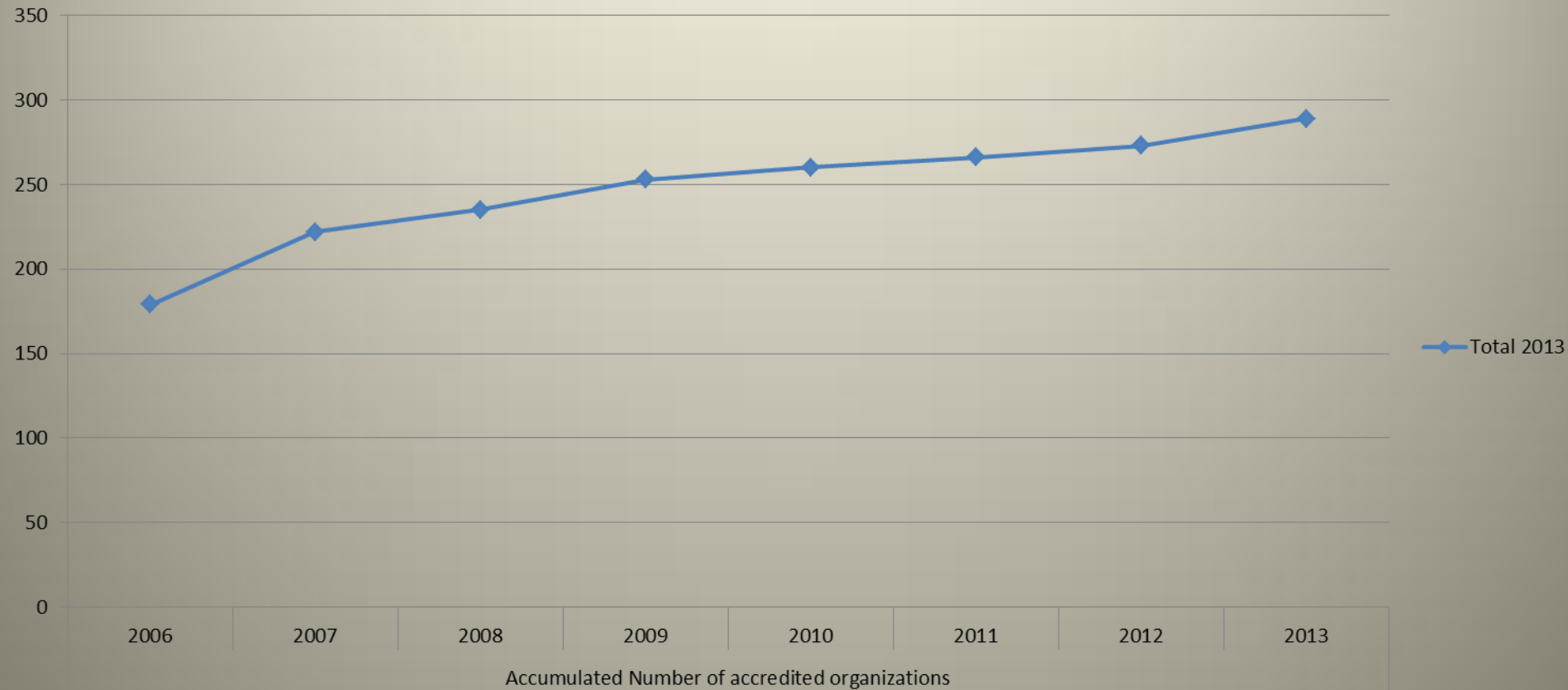

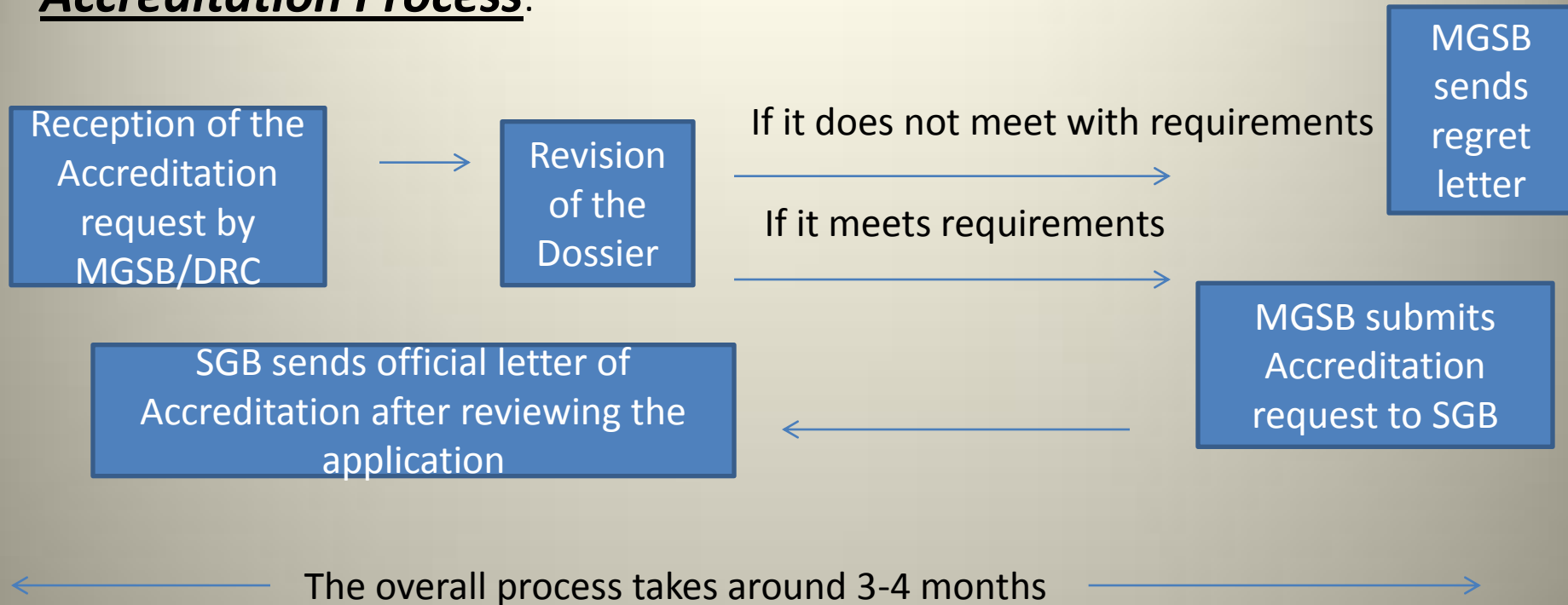

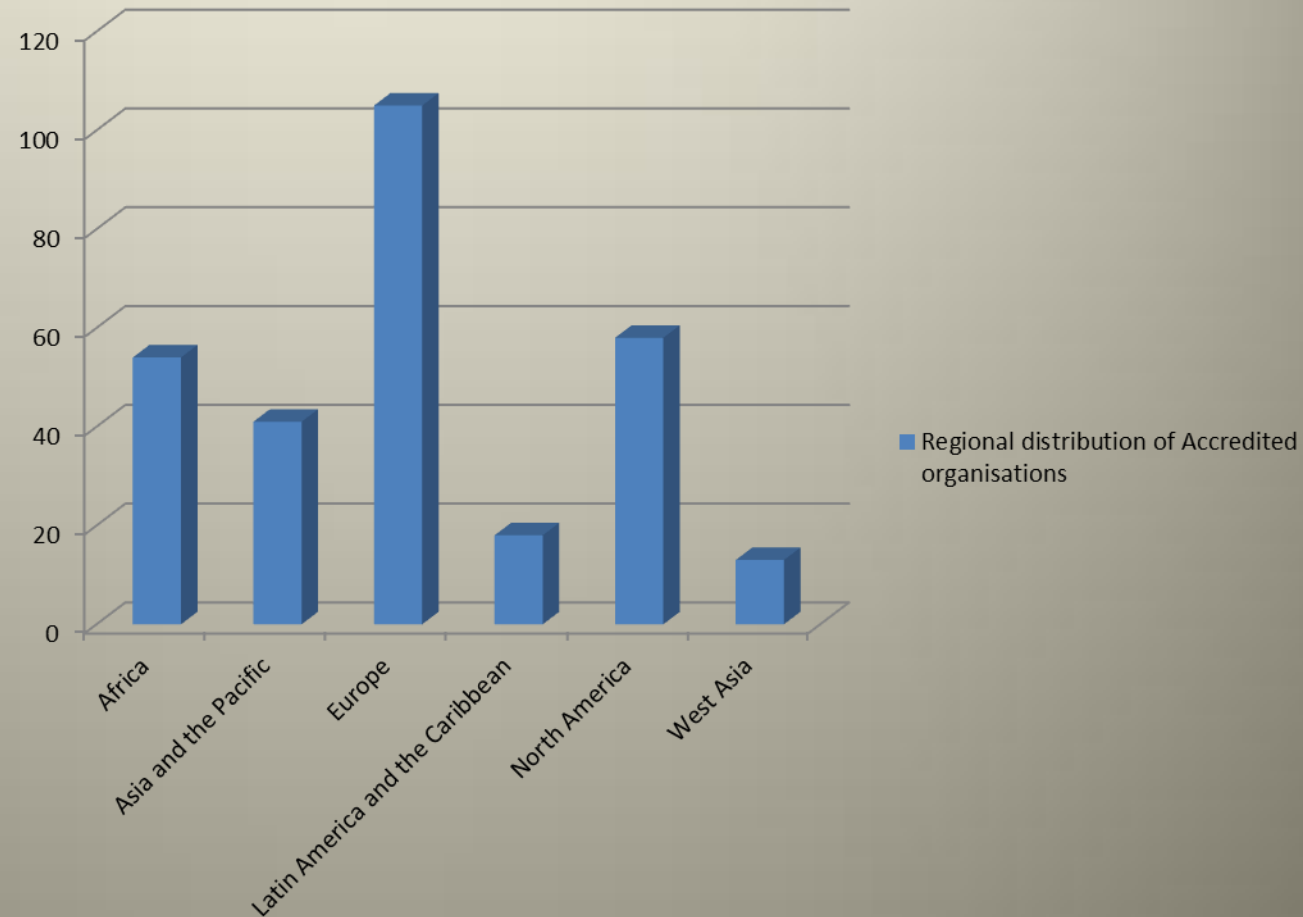

Regional distribution of accredited organizations

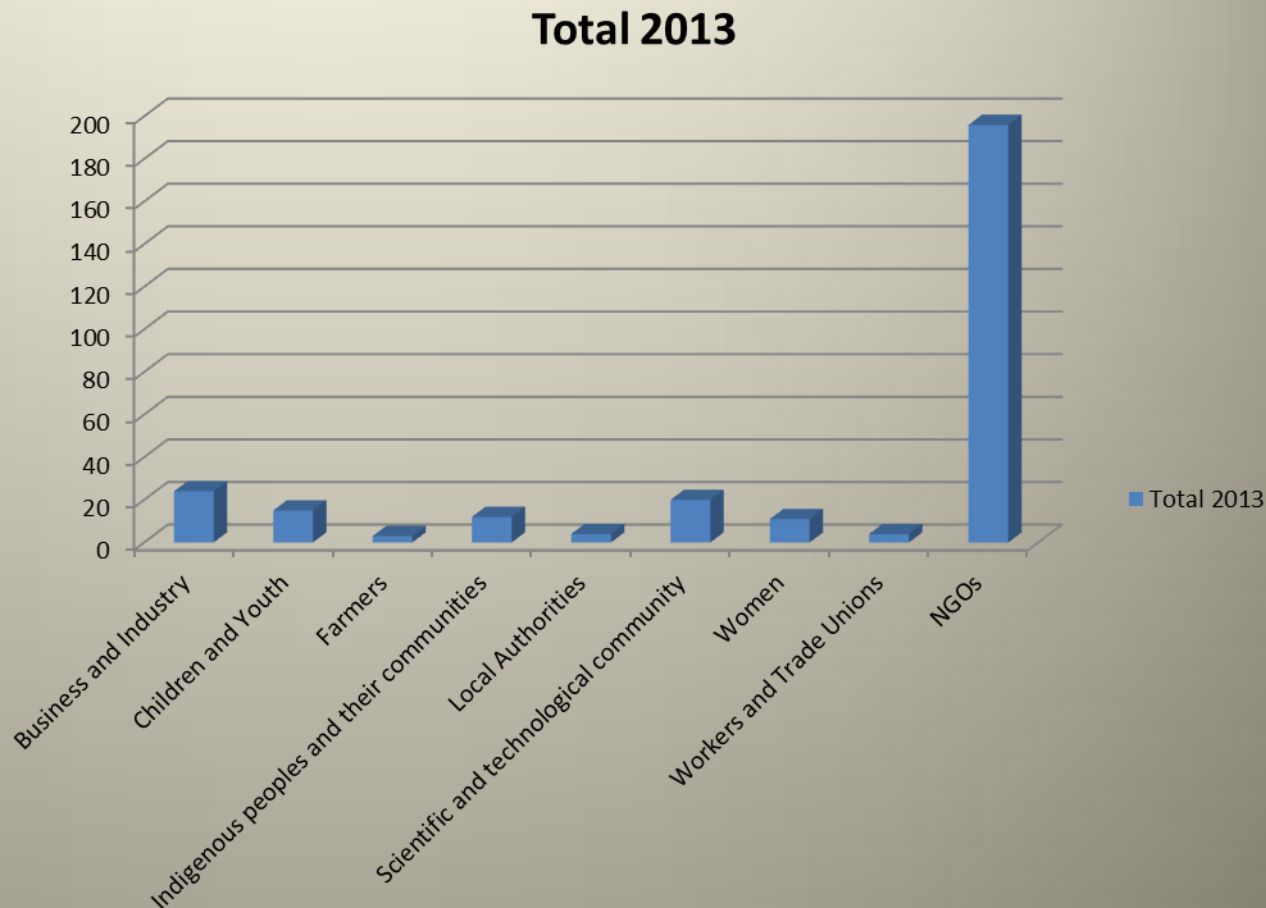

Regional distribution of Accredited organisations

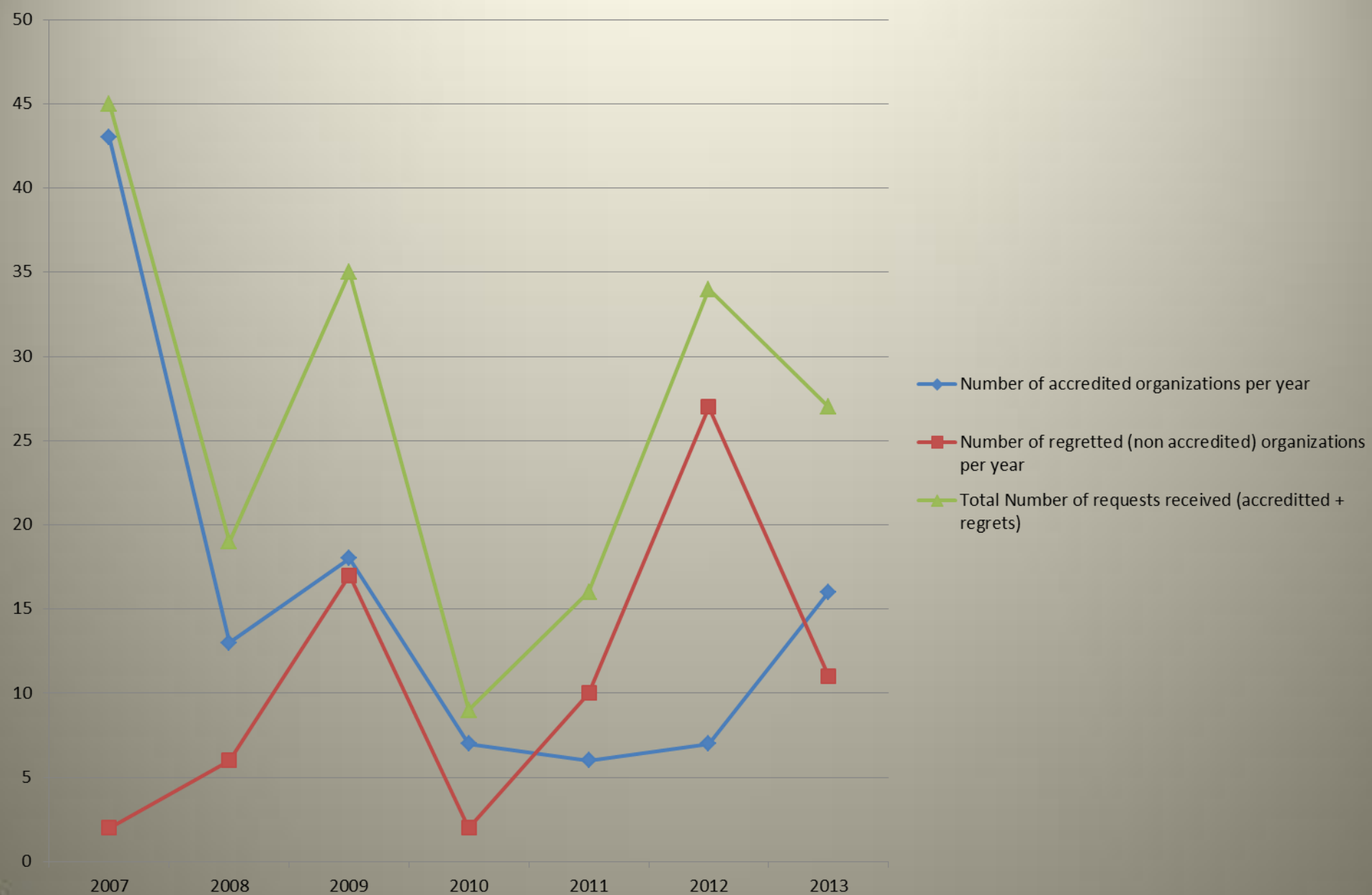


Distribution of Accredited organization by Major Group
